Whereas, pursuant to an agreement between the contestant and the Miss Alabama's Outstanding Teen Competition
contestants have waived all rights in and to the use of their names and likenesses in connection with the Competition
and any commercial activity emanating therefrom;

Now, therefore, for good and valuable consideration, the receipt and sufficiency of which are acknowledged, the parties
agree as follows:

1. Photographer hereby assigns to Miss Alabama's Outstanding Teen all right, title, and interest worldwide in and
to the photographs of the Competition contestant, including the copyright as a coowner with the photographer.
Photographer expressly acknowledges that upon creation of the photographs, Miss Alabama's Outstanding Teen
shall have all rights of ownership in and to the photographs, including but not limited to the right to reproduce,
display, and distribute them in any medium at Miss Alabama's Outstanding Teen's sole discretion, and to
incorporate them into any other work or to make derivative works from them. Photographer acknowledges that
the photographs may be incorporated into commercial works or merchandise, publicity materials, posters,
brochures, or other material or uses, which Miss Alabama's Outstanding Teen in its sole discretion shall deem
appropriate. Photographer agrees that Miss Alabama's Outstanding Teen does not require the consent of the
Photographer to make any such use.
2. Photographer shall not assert any claims or moral rights (droit moral) in connection with the photographs.
Notwithstanding the foregoing, Miss Alabama's Outstanding Teen shall, if possible, provide bylines or give credit
to the Photographer when use of the photograph is made. However, the failure of Miss Alabama's Outstanding
Teen to credit the Photographer shall not be a violation of the Agreement
3. The agreement shall be binding, valid and enforceable against, and the benefits there shall inure to, the parties,
licensees, assigns, and parties in privity with them.
