Photographer expressly acknowledges that upon creation of the photographs, Miss Alabama's Outstanding Teen shall have all rights of ownership in and to the photographs, including but not limited to the right to reproduce, display, and distribute them in any medium at Miss Alabama's Outstanding Teen's sole discretion, and to incorporate them into any other work or to make derivative works from them. Photographer acknowledges that the photographs may be incorporated into commercial works or merchandise, publicity materials, posters, brochures, or other material or uses, which Miss Alabama's Outstanding Teen in its sole discretion shall deem appropriate. Photographer agrees that Miss Alabama's Outstanding Teen does not require the consent of the Photographer to make any such use. 2. Photographer shall not assert any claims or moral rights (adroit moral) in connection with the photographs. Notwithstanding the foregoing, Miss Alabama's Outstanding Teen shall, if possible, provide bylines or give credit to the Photographer when use of the photograph is made. However, the failure of Miss Alabama's Outstanding Teen to credit the Photographer shall not be a violation of the Agreement 3.
